June 3rd, 2020 - under the control of an official authority or when permitted under eu or member state law any prehensive register of criminal convictions may be kept only under the control of official authority member states may impose restrictions on the processing of personal data for the purposes of enforcing civil law claims'

June 7th, 2020 - the eu can only act within the limits of the petences conferred on it by the treaties and where the treaties do not confer petences on the eu they remain with the member states article 5'

June 2nd, 2020 - european labour authority council adopts founding regulation the council adopts a regulation establishing a european labour authority ela the aim of this new body is to support pliance and coordination between member states in the enforcement of eu legal acts in the areas of labour mobility and social security coordination''authorities legal definition of authorities

June 4th, 2020 - authorities governmental entities that have been created and delegated with official responsibilities such as a county highway authority in legal research and citation entities cited as sources of law such as statutes judicial decisions and legal textbooks''european union

June 3rd, 2020 - does eu law take precedence over uk law when the six founding european states created the european economic munity in 1957 they did so in the form of an international treaty known as the treaty of rome that was binding between them that treaty also created the european court of justice in an important ruling in 1964 the court said that the states had agreed to limit their sovereign''**supremacy of eu law eurofound**

June 5th, 2020 - the legal doctrine of supremacy of eu law means that eu labour law takes precedence over domestic labour law the creation of a new legal order of eu law and its supremacy means that eu institutions may create rules affecting employment and industrial relations even where some member states oppose such rules and vote against them in those eu institutions provided that a voting procedure''home garante privacy

June 8th, 2020 - the italian data protection authority garante per la protezione dei dati personali is an independent administrative authority established by the so called privacy law law no 675 of 31 december 1996 and regulated subsequently by the personal data protection code legislative decree no 196 of 30 june 2003 as amended by legislative decree no 101 of 10 august 2018 which also established''**regulations directives and other acts european union**
